

MEMORANDUM OF UNDERSTANDING










Purpose of Cooperative Agreement between AIPS and IUCPSS

community at US and Pakistani academic institutions.




GENERAL TERMS OF EXECUTION

The American Institute of Pakistan Studies and the IUCPSS agree to cooperate on the following;



The AIPS in collaboration with HEC and IUCPSS will organize doctoral dissertation writing workshops in Pakistan for Pakistani students where AIPS will invite a prominent US scholar to lead the workshop. The workshop leader than would be invited to some selected IUCPSS member campuses for faculty meetings and seminars.







The AIPS and IUCPSS agree to co-organize series of academic talks and seminars of these visiting US researchers at selected IUCPSS member campuses.



The AIPS and IUCPSS offices in Islamabad will coordinate with host institutions in Pakistan in connection with organization of the proposed academic seminars and workshops in Pakistan.



The AIPS will encourage and facilitate academic partnerships between consortia-member universities of AIPS-US and IUCPSS-Pakistan. This may include but not limited to "faculty exchange, student exchange, split degree and research, video conferencing and joint certificate/diploma programs.



AIPS will provide research internships to the scholars/ researchers from the member institutions of IUCPSS in the research projects by American scholars supported by AIPS in Pakistan.



Both parties agree to appoint Mr. Murtaza Noor as IUCPSS focal person for facilitation and coordination among IUCPSS member institutions and AIPS.

ANNUAL REVIEWS

In order to assure progress in attaining the goals described in this MoU, it is agreed that AIPS and IUCPSS will annually review the scope and progress of cooperative activity.



TERM

This MoU shall last for an initial period of 3(three) years from the Effective Date. Either party is free to withdraw at any time during the initial period upon one (1) year prior written notice to the other party of its intention to withdraw.



AMENDMENTS

Amendments to this MoU may be proposed, either by the undersigned or their successors or nominees, and shall become effective only if agreed to, in writing, by the undersigned or their successors or nominees
